## **INDEPENDENT AUDITOR'S REPORT**

### **To the Members of SARVLOK COMMERCIAL LIMITED**

#### **Report on the Financial Statements**

We have audited the accompanying financial statements of **SARVLOK COMMERCIAL LIMITED** ('the company'), which comprise the balance sheet as at 31 March 2016, the statement of profit and loss and the cash flow statement for the year then ended, and a summary of significant accounting policies and other explanatory information.

#### **Management's Responsibility for the Financial Statements**

#### **Auditor's Responsibility**


Our responsibility is to express an opinion on these financial statements based on our audit.

An audit involves performing procedures to obtain audit evidence about the amounts and the disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal financial control relevant to the Company's preparation of the financial statements that give a true and fair view in order to design audit procedures that are appropriate in the circumstances, An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of the accounting estimates made by the Company's Directors, as well as evaluating the overall presentation of the financial statements.


i. the Company does not have any pending litigations which would impact its financial position;

The Annexure referred to in our Independent Auditors’ Report to the members of the Company on the financial statements for the year ended 31 March 2016, we report that:


1. As the company has no fixed Assets, so clause is not applicable to the company.

### **Report on the Internal Financial Controls under Clause (i) of Sub-section 3 of Section 143 of the Companies Act, 2013 ("the Act")**


## Inherent Limitations of Internal Financial Controls over Financial Reporting
