INDEPENDENT AUDITOR'S REPORT

To the Members of
SARVLOK DEALCOM LIMITED

Report on the Financial Statements

We have audited the accompanying Ind AS financial statements of **SARVLOK DEALCOM LIMITED** ("the company"), which comprise the Balance Sheet as at **31st March 2018**, the Statement of Profit and Loss (including other Comprehensive Income), the Cash Flow Statement and the Statement of changes in Equity for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

The Company's Board of Directors is responsible for the matters stated in section 134(5) of the Companies Act, 2013 ("the Act") with respect to the preparation and presentation of these Ind AS financial statements that give a true and fair view of the financial position, financial performance of the Company in accordance with the accounting principles generally accepted in India, including the Indian Accounting Standards (Ind AS) specified under Section 133 of the Act, read with Rule 7 of the Companies (Indian Accounting Standards) Rules, 2015, as amended. 


Inherent Limitations of Internal Financial Controls Over Financial Reporting

NOTE NO. 1

1. Basis of Preparation and Compliance with Ind AS

1.1 Statement of Compliance

The Company has adopted Indian Accounting Standards (referred to as "Ind AS") notified under the Companies (Indian Accounting Standards) Rules, 2015 (as amended) read with Section 133 of the Companies Act, 2013 ("the Act") with effect from April 1, 2017 and therefore Ind ASs issued, notified and made effective till the financial statements are authorized have been considered for the purpose of preparation of these financial statements.

These are the Company's first Ind AS Standalone Financial Statements and the date of transition to Ind AS as required has been considered to be April 1, 2016.

In accordance with Ind AS 101-"First Time adoption of Indian Accounting Standards" (Ind AS 101), the Company has presented a reconciliation of Shareholders' equity as given earlier under Previous GAAP and those considered in these accounts as per Ind AS as at March 31, 2017, and April 1, 2016 and also the Net Profit as per Previous GAAP and that arrived including Other Comprehensive Income under Ind AS for the year ended March 31, 2017. (Reffer No. 15)

2. Significant Accounting Policies

2.1 System of Accounting :

The financial statements have been prepared under historical cost convention excepting certain financial instruments which are measured in terms of relevant Ind. AS. The Accounts has been prepared on the concept of going concern.

2.2 Revenue Recognition :

Item of Income/Expenditure are recognised on accrual basis.

2.3 Retirement Benefit :

Retirement benefits are not provided in the books. It is provided as and when it arises.

2.4 Contingent Liability :

Contingent liabilities are not provided in the books. It is disclosed by way of notes to the financial statements when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or when there is a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the same or a reliable estimate of the amount in this respect cannot be made.

2.5 Miscellaneous Expenditure :

Preliminary expenses will be amortised as and when they are incurred.

2.6 Deferred Revenue Expenditure :

Deferred Revenue Expenditure are amortised as and when they are incurred.

2.7 Taxes on Income :

Income tax expense representing the sum of current tax expenses is recognized in the income statement except to the extent that it relates to items recognized directly in equity or other comprehensive income.

Current income tax is provided on the taxable income and recognized at the amount expected to be paid to or recovered from the tax authorities, using the tax rates and tax laws that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities in the Financial Statements and the corresponding tax bases used in the computation of taxable profit. The Company doesnot have any case of timing difference during the year, provision of deferred tax is not applicable.

2.8 Earning per share:

Basic earnings per share are computed by dividing the net profit attributable to the equity holders of the company by the weighted average number of equity shares outstanding during the period. Diluted earnings per share is computed by dividing the net profit attributable to the equity holders of the company by the weighted average number of equity shares considered for deriving basic earnings per share and also the weighted average number of equity shares that could have been issued upon conversion of all dilutive potential equity shares
